Our organization's goals and objectives revolve around being responsive to the needs of northeast Ohio's refugee community in order to forge a deep and sustaining impact on resettled refugees as they make new roots and re-write the story of their families' futures to one of freedom from persecution and finding security and self-sufficiency. The organization's programs such as the Ohio City Farm, the Adult Tutoring Program, Corner65, the Youth Mentoring Program, and Teen Response are critical to both the short- and long-term economic success and the social and emotional assimilation of these NEO community members.

As a Sports Specialist, you will play a pivotal role in organizing and facilitating a newcomer youth health and wellness program.

Responsibilities:

Logistics and Transportation:

Collaborate with Corner65 Director & Program Coordinator to coordinate transportation logistics

• Oversee up to 20 students individually during program sessions with the support of volunteers/staff.

Equipment and Gear:

- Organize gear, ensuring each item is labeled for easy access.
- Distribute and collect gear before and after each session.

Student Support & Engagement:

- Ensure the safety and well-being of participants, keeping track of their whereabouts.
- Assist with snack distribution and immediate needs during programming.
- Foster a positive and inclusive environment for participants.

Program Administration:

- Track and record attendance for each session, compiling comprehensive reports.
- Deliver program practices or stations for sports/arts programming. This includes Corner65's Summer Camp- Game ON. Coordinate with the Program Director to receive practice plans or create practice/program plans & ideas.
- Collaborate with Corner65 Director to make necessary adjustments to programming.

Coordination & Communication:

- Coordinate independently up to 20 students during program sessions, ensuring their safety and well-being with the support of volunteers/staff.
- Keep track of the whereabouts of all participants and accompanying staff/volunteers at all times to maintain a secure environment.
- Maintain open and effective communication channels with all contributors.
- Work closely with the Corner65 Director to address programming-related needs or concerns.
